CALL TO ORDER

PRESENTATIONS

A. CITY UPDATE

Laura Solano, Chief of Staff

- COVID update: last 7 days positivity count: 247, 11.2% positivity rate, 9 days of stabilized hospitalizations
- Declaration of public housing for the next 2 days for Crazy Faith Ministries to open their doors to the homeless with the cold weather
- ARPA trash update: Coordinator position closed; 13 applicants, 7 approved. Exam scheduled for tomorrow, then interviews will occur once the list has been completed. Trash supplies have been purchased, including 1 truck; working on second truck.

Ms. Solano answered questions and addressed comments from Council.

B. MOBILE CRISIS UNIT

Teah Miller, Director of Crisis Services - Health Solutions
Heather Higgins, Chief Operating Officer - Health Solutions

Ms. Miller reviewed the new federal guidelines for crisis continuum response for the community. 988 is the Colorado Crisis line for those calling with a Colorado area code. Triage on phone and does a warm handoff to local mobile team for in-person crisis intervention. Followup is completed within 24 hours. Ms. Miller also reviewed the options the mobile team can provide.

- a. Municipal regulation of abortion clinics; and
- b. A proposed amendment to the City Charter.
